

## Terms & Conditions for Meet and Greet with Pierre Gasly - organized by FlowBank SA

---

1- The organizer is FlowBank SA whose registered office is at Esplanade de Pont-Rouge 6, P.O. Box 1303, 1211 Geneva 26, Switzerland.

FlowBank SA organizes a drawing from 20 June to 30 June 2023 for existing FlowBank clients that refer a friend to open a FlowBank account before June 30th. The winner of this drawing will be able to invite up to 1 maximum guest from their "refer a friend" list who had created an account.

2- This drawing is open to any active FlowBank client. This drawing is not available to employees of FlowBank SA and their close relatives and anyone otherwise connected with the organization, regardless of their status as clients.

3- Each client can refer up to 3 friends to open an account. Regardless of whether more than one referred individual opens an account, the winner of the drawing will be only able to invite one of their referred friends. Clients must use the email address associated with their FlowBank account to enter the drawing.

4 - The closing date and hour to participate in the drawing will be 30.06.2023, 11:59 PM CET. After this date and hour, no further entries to the drawing will be allowed.

5- No responsibility shall be incurred by FlowBank SA for entries not received or not received on time for whatever reason.

6- The winner will be chosen randomly by an electronic random generator (Google generator number), after having been selected among all the entries received and verified by the organizer that match the requested steps of the game.

7- The organizer reserves the right to cancel or amend the drawing without notice in the event of a catastrophe, war, civil or military disturbance, act of God, or any actual or anticipated breach of any applicable law or regulation or any other event outside of the organizer's control. Any changes regarding the drawing's rules will be notified to participants as soon as possible by the organizer.

Besides FlowBank SA shall have the right, at its sole discretion and at any time, to change or modify these terms and conditions. Such a change shall be effective immediately upon posting to this webpage.

8- There will be 3 client's winners for this drawing, which will include travel (except from the United States, Canada, Japan or from any country or jurisdiction where the participation to this drawing would be contrary to local laws or regulations), accommodation, access to the Hungarian Grand Prix event scheduled for 21-23 July. The participation to the event will include up to 1 day's access to Hungarian Grand Prix race in Budapest, Hungary, with a short introduction to Pierre Gasly on site, where photos can be taken. Food and beverages during the stay are not included. No cash will be offered. The prize is not transferable. The prize is subject to availability, and we reserve the right to substitute it with another prize of equivalent value without giving notice.

If the winner cannot be contacted or does not claim his/her prize within 4 days following the notification, the organizer reserves the right to withdraw the prize from the winner and allocate it to a new winner. 10- The organizer will notify the winner when the prize can be delivered and where it can be collected.

Any personal data relating to the winner, will be used in accordance with current Swiss data protection legislation and will not be disclosed to a third party without the participant's prior consent.
