Having an account with FlowBank is always free - regardless of funds added and instruments used. That said, you do need to keep in mind several service fees when executing your trades:

Transfer OUT of securities	45 CHF / 45 EUR / 45 USD other currencies: equivalent to 45 CHF per position
Transfer IN of securities	Free of charge
Change of stock exchange	45 CHF / 45 EUR / 45 USD other currencies: equivalent to 45 CHF per position
Transfer of physical Shares	190 CHF / 190 EUR / 190 USD + taxes other currencies: equivalent to 190 CHF + taxes per position
Tax report	By request
Closing Fees	15 CHF/ 15 EUR /15 USD

Note: Keep in mind that some charges may arise before the money reaches your FlowBank account. Such charges may be applied by an issuing, intermediary and/or beneficiary bank that process wire transfers. Please contact your bank if you are unclear about transfer costs.
